- As a Coach for Space Coast United Soccer Club I agree to:**
1. Comply with all Florida Youth Soccer Association (FYSA), Brevard Youth Soccer League (BYSL) and Space Coast United Soccer Club (SCUSC) rules/guidelines.
 2. Comply with SCUSC Board of Director's direction/decisions.
 3. Comply with the Program Director's Operating Plan.
 4. Ensure that my coaching staff and I conduct ourselves in a professional manner at all times and adhere to the FYSA Coach's Code of Ethics (found on the back of this form).
 5. Promote the game of Soccer as it is intended, which includes the following examples:
 - a. Good sportsmanship (alcohol or profane language will not be tolerated)
 - b. Teamwork
 - c. Teaching skills of the game
 - d. Have Fun
 6. Ensure the safety of players, which includes the following examples:
 - a. Wearing shin guards at games and practices
 - b. Ensure goals are anchored when used
 - c. Not allow players to dangle from goals or on nets
 - d. Allow only registered players to practice and participate in games.
 7. Communicate with team parents as required.
 8. Control parents, players, Assistant Coaches, and anybody else associated with my team.

Failure to comply with the above contract could result in disciplinary action(s).

Code of Ethics

All Coaches will be bound by the following Code of Ethics while participating in FYSA Sanctioned events



Coaches/Volunteers

- o I will never place the value of winning before the safety and welfare of all players
- o I will always show respect for players, other coaches, and game officials.
- o I will lead by example, demonstrating fair play and sportsmanship at all times.
- o I will demonstrate knowledgeable of the rules of the game, and teach these rules to my players.
- o I will never use abusive or insulting language. I will treat everyone with dignity.
- o I will not tolerate inappropriate behavior, regardless of the situation.
- o I will not allow the use of anabolic agents or stimulants, drugs, tobacco, or alcohol by any of my players.
- o I will never knowingly jeopardize the eligibility and participation of a student-athlete.
- o Youth have a greater need for example than criticism. I will be the primary soccer role model.
- o I will at all times conduct myself in a positive manner.
- o Coaching is motivating players to produce their best effort, inspiring players to learn, and encouraging players to be winners.
- o Coach's actions on sidelines during games shall be in the spirit of "good sportsmanship" at all times. Profanity, profane gestures, arguing, inciting disruptive behavior by spectators and/or players, or any conduct not in the spirit of good sportsmanship, shall require disciplinary action from the affiliate.
- o Alcohol, illegal drugs and unauthorized prescription drugs shall not be possessed, consumed or distributed before, during or after any game or at any other time at the field and/or game complex.
- o I will refrain from any activity or conduct that may be detrimental or reflect adversely upon FYSA, its members or its programs.
- o I will accurately and completely complete the coach/volunteer application form and by application attest to the accuracy of the information submitted.

Failure to comply may result in the suspension of your privilege to participate in FYSA sanctioned events, for the following periods:

- 1st offense suspension minimum thirty (30) days to a maximum of five (5) years
- 2nd offense suspension for a minimum of one (1) year to a maximum of Ten (10) years
- 3rd offense suspension for a minimum of five (5) years to a maximum of fifty (50) years.

NOTE: Any individual charged with a violation of this Code of Ethics shall be afforded due process as defined in FYSA's rule section 600 before the implementation of any suspension.
